The Company may conduct an introductory familiarization program / presentation, when a new Independent Director comes on the Board of the Company.

This Policy shall be uploaded on the Company’s website, if any, for public information and a web link for the same shall also be provided in the Annual Report of the Company.

All the information and documents as and when sought by the IDs are promptly provided. All the relevant and important information is placed before the Board / Committees to enable them discharge their functions efficiently and effectively.

During the financial year 2025-26, familiarization programs was made to IDs of the Company on Annual budgets, Review of Operations and state of affairs of the Company and updation on Companies Act, 2013 and other allied Rules framed thereunder and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other regulations, as amended from time to time.
